The Adopting Family (AF) acknowledges that the purpose of this agreement is to safeguard the health and well being of the dog and to protect it against neglect, abuse and cruelty, and enters into this agreement freely and with good will. This agreement relates to the following dog and is between Northern California Animal Rescue Friends (NCARF) and the AF identified below:

The AF agrees that this dog will receive the care and attention necessary to ensure its health and well being. The AF agrees that this dog will be a house pet, will be kept in good condition, and at the proper weight. The AF agrees to provide, at all times, sufficient food, water, exercise, medical care, up-to-date vaccinations, current and legible ID tags or other identification, licenses(as required by local authorities), and any other necessities consistent with responsible pet ownership. The AF also agrees that for safety purposes, this dog will be transported in a crate.

The AF agrees that this dog will not be abused and will never be used for any commercial or scientific (medical research) purposes. The AF shall not sell or abandon this dog. (NCARF or NCARF Foster Parents should be contacted if the AF wishes to relinquish custody of the dog. NCARF will make every effort to take the dog back whenever possible.)

The AF understands that failure to comply with the conditions outlined in this Agreement will result in the removal of this dog from their custody. NCARF reserves the right to reclaim the dog in the event of neglect, abuse, cruelty, or unpaid adoption fees.

The AF acknowledges that this dog has been accepted for adoption and that NCARF has no knowledge concerning the background or previous environment of this dog (if obtained from a shelter) and has only the word of the previous guardian(s) concerning the background or previous environment of this dog (if from a private home). NCARF in no way warrants or guarantees this dog and makes no representation or warranties regarding the temperament or stability of this dog, or makes any representation regarding the health or condition of the dog. The AF accepts the dog "as is" and hereby releases, discharges, and holds harmless the NCARF, their representative(s), and agents, from any and all claims, damages, costs, and expenses the AF, their agents, or representatives now have or may hereafter accrue as a result of the adopted dog's actions, behavior, health, and damages or injuries resulting there from.

The Adopting Family, as of the date of this agreement, assumes full responsibility and liability for the dog and its actions.
